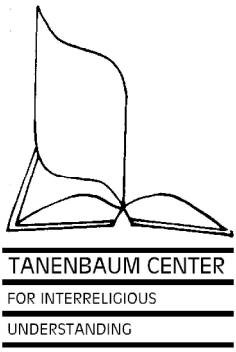

In addition, the recipient of the Peacemakers in Action award will be asked to provide a brief summary on how he/she will use the monetary award to further his/her peacemaking work.
